As we put this edition of the Pipeline out, I'd like to thank the membership for the opportunity to serve for another term as the Business Manager of Local 17.

2019 has been a busy year with politics. We had an election as a local that President McManus did a great job in conducting. In this year's local election, we had a few transitions and welcomed several new part-time officers. All the Full Time Officers look forward to

working with our new e-board members, union trustee and CFL delegate as they start their first terms. And welcome back all the incumbents who won re-election!!!

We have been busy in State Politics as well. All the Local's Full Time Staff worked hard to promote and gain support for the Hazardous Material Training Act. The first state to pass this legislation was California in 2013 and it was recently passed in Washington State. Several other states seem likely to enact very similar legislation soon. Our version of the legislation (SB 1407) was passed in the Illinois State Senate but did not receive a vote in the Illinois House before the end of the session in May. We will continue working with the Illinois AFL-CIO and other Building Trades Unions to seek passage of this Bill in the upcoming Fall Session in Springfield.

The Bill if made law, will require facilities in Illinois that could pose a serious safety risk to workers and the communities where they are located to hire trained craftsmen and women as contract workers. This would require a workforce that has either graduated from an approved apprentice program in one of the recognized crafts or workers who are able to demonstrate a length of service in a craft that shows they are skilled in that type of work. The Bill will go a long way to

help maintain a safe plant for the workers and the people who live in those surrounding communities. The Public deserve no less than the safest facilities as neighbors. If the bill is passed there will be a required safety training for all workers including Local 17's Members in order to work in these facilities. In California they adopted a 20-hour Training Class as a result of the law. We expect something similar will be required in Illinois. This is not a Union only bill but rather a bill requiring a trained and skilled workforce.

Our International has reached an agreement with the Sheetmetal Workers International Union. The Agreement dated June 1, 2019 provides that all metal lagging on piping or vessels that is $.020 (\le .020)$ and lighter will be the work of the Insulators. Anything greater than .020 (>.020) will be the work of the Sheetmetal Workers. It further re-establishes our International's claim to the insulation applied to the outside of ductwork, fan housings, fresh air intakes, plenum chambers etc. on the job site as being recognized as the jurisdiction of the Insulators. Further it states that the Sheetmetal Workers will cease to claim duct or pipe insulation and that the training of our craft in their apprentice programs will also cease. After over 5 years of disputes on jurisdictional boundaries this agreement promises to end those problems.

This year at the Chicago and Cook County Building Trades Softball Tournament they are looking to make it a more family-oriented event. So, if can make it July 13th, 2019 it is held at the St. Christina Fields located at 111th and Central Park in Chicago. They promise food and drinks, clowns, balloon animals and face painting along with an inflatable slide and jumping jack for your younger family members. Any monies made at the event will be donated to Dollars Against Diabetes.

I would also like to encourage our members to attend one of the Labor Day events we will be participating in. On Saturday, August 31st, 2019 we will be joining the Southeast Side Labor Day Parade. This year's event will be a project of the Chicago Federation of Labor and Alderwoman Susan Garza of the 10th Ward. The day will begin with a parade at 12 noon followed by Eddie Fest at Calumet Park on 9801 S. Avenue G in Chicago. More information will be forthcoming on the event. This year Local 17 will have our Float at the Lowell, IN Parade on Labor Day. And our Peoria Members will be marching in their event on Labor Day alongside Ben Frank who will be our Parade Captain there.

THOMAS McGRATH - SECRETARY-TREASURER

First, I'd like to review 2018 hours for Local 17. The Local finished working 1,429,936.57 hours in Local 17's jurisdiction and 1,492,578.49 hours total with reciprocated hours around the country. That comes out to 62,641.92 hours reciprocated from other insulator Local's around the country. Local 17 is grateful for those opportunities. Those reciprocated hours helped our members by putting a paycheck in their pockets and continued contributions into their benefits. Currently the local has filed our taxes for 2018 and have had our annual audit prepared. I'm happy to report that the Local finished the year good financially.

As far as our start of the 1st and 2nd quarters of 2019 our hours are down. Due to projects being held up for weather issues for the most part. All indications tell us that this summer and late 3rd quarter work should pick up.

I'm happy to report that the re-sealing and painting on the building that was approved last year has been completed. That will leave us with one more task of getting our parking lot repaved. Our officers and trustees will address this later this year.

I'd also like to congratulate all the candidates on their elections I know all will do a great job for Local 17.

I would like to address some of the questions that have been brought to my attention concerning the Pension Plan our defined benefit.

Trustees Continue to Seek Ways to Strengthen Your Pension Plan

Your pension plan has been in existence for over 60 years and is currently paying benefits to more than 850 members, including beneficiaries of deceased members. Along with the health insurance and annuity plans, the pension plan is one of the key elements of a secure retirement. Accordingly, the Trustees closely monitor the pension plan to make sure it remains strong. Over the years, they have made many decisions, some of them difficult, all designed to provide stability and benefit security for you and your families. For example, decisions the Trustees made following the "dot-com bubble" in the early 2000s and the financial crisis in 2008 have put the Plan in a position not only to maintain the level of benefit accrual but also increase it over the last 10 years. This was not the case for other multiemployer pension plans, many of which have had to cut benefits multiple times. In fact, some plans continue to struggle to maintain lowered benefit accruals to this day. Fortunately, your Plan has done extremely well but it is important to note that headwinds continue to be a concern for all pension plans, including:

- · Potential investment volatility
- Member retirements that create an imbalance of inactive to active participants
- Potential for declining active membership and non-union pressures that could impact number of hours (lower contributions and increased benefit payments put additional pressure on investment performance to fund benefits)
- Potential for considerably higher Pension Benefit Guaranty Corporation premiums, which create additional administration expenses

The Trustees are constantly monitoring ways to strengthen the pension plan to determine ways for it to continue to succeed despite these headwinds. Although the Trustees were able to avoid cutting benefits after 2008, what if another significant downturn in the stock market/economy happens? Will the Plan be in position to withstand these pressures again? With that in mind, the Trustees are working with their Fund professionals to look at alternative ways to ensure pension benefits are paid to its members. **The pension plan is not going away.** The Trustees are simply looking at ways to make sure of that, not only in the short-term, but for the next 60 years.

JAMES McMANUS – PRESIDENT/BUSINESS AGENT

I've been spending time educating myself on the I.E.C.C (Illinois Energy Conservation Codes). Currently Illinois follows the 2015 version with the 2018 going into effect May 1, 2019. This is a tool that if followed, we could gain more of our market. I've talked with building/plumbing inspectors from different cities, towns, villages and municipalities on this subject and a lot of times parts of the codes are overlooked. As far as the in-wall insulation, once the drywall is up nobody can see the energy loss or the potential mold growth within the walls. This is a concern on both hot as to save energy and cold to prevent condensation which can breed mold. I know some projects like to "value engineer" and they will carve out insulation. Omitting insulation is exactly the opposite of "value engineering". In terms of being an oxymoron it rates right up there with "right-to-work". More insulation, not less or none would give you more value. The health and safety of this might not be apparent at the time they omit insulation but could become a problem further down the road. I will continue to bring this up to owners/end users and general contractors. Sometimes things that are right in front of you just

need to be pointed out.

On the political end, I joined my partners down in Springfield quite bit these last couple of months in support of Senate Bill 1407 HAZ-ARDOUS MATERIALS WORKFORCE. That's the safety bill we've been promoting. Illinois and the surrounding communities of these plants deserve to have a safe and qualified workforce to perform the work in these highly hazardous facilities. Our members work, day in and day out in these plants alongside untrained and unqualified workers. While this bill won't prevent accidents from happening, it can greatly reduce them. We shouldn't have to wait for an accident to happen before we react. It passed though the Senate but got hung up in the House for now. Hopefully when they get back in session, they see the value of the safety driven bill and make it a law.

In closing, I'd like to say thank you to all the candidates that ran in our Local Union's election. Congratulations to those who came out on top in their elections. And to thank all of the hard-working members for going to work and putting in a day's work for a day's pay.

The Petrochem campaign continues. Our International has taken over discussions with the International that represents Petrochem. Local 17 is monitoring progress achieved by the respective Internationals. Members will be kept updated as to their ongoing efforts to reach a resolution. I would personally like to thank all the members that came out to support the campaign. Their actions showed the community what it means to be a Union Insulator.

One of our members worked on a campaign to gather information on a non-union company. This member worked "undercover" for a company owner that exploited its workers. These actions went unchecked until this member exposed the owner for who he is. Now, this company is under investigation in multiple states. I hope more of our brothers and sisters will step-up and help expose other companies

who feel the rules don't apply to them. If you are interested in getting involved further on this ongoing campaign, please let me know.

Brother Brian Keane and I received multiple calls regarding work being performed by non-union groups on "mixed bag" jobs. The first involved two workers that had questions about the Union. These two young men were working for low wages and little benefits. They weren't provided with the proper equipment to do the job safely. Having an opportunity to speak with them, their views about unions changed. Our organization continues to keep in contact with these people. We want non-union workers to know that the non-union contractor is the enemy, not Unions. The second situation dealt with a non-union plumber. The work was subpar (putting it nicely). We gained access on the job and began gathering evidence which was shared with an Alderman and a City Inspector. The work had to be redone properly and pass inspection. This resulted in unnecessary cost — both in time and money. We need to do more to be a thorn in the side of companies that want to cut corners at the cost of our craft. If these situations arise on your job site, please let me know. Together, we can do our best to help our cause.

We discussed Pension, Social Security, Pre-Medicare Retiree Insurance and Medicare insurance. In addition, how to offset your living expenses with your Annuity Account was discussed. It was very informative and beneficial. If you have not attended yet, and you are planning to retire within the next few years, please plan on attending the next Retiree Seminar. A notice will be sent once the date is scheduled.

LOW DOSE CT SCANS

As of this writing, there are only a few spots remaining for the Low Dose Ct scan in November. All others have been booked through the end of the year. We have started a cancellation list that we can add your name too. We will send out an update as soon as the 2020 dates become available. We encourage those that are eligible to take advantage of this great benefit.

HRA/VEBA

I would like to remind everyone how to file an HRA claim: the *participant* must submit a note requesting withdraw of monies from the HRA account. The specific dollar amount can be requested, or the member can request that the account be maxed out. The member must sign and date the letter and include his/her alternate I.D. number. The Fund office will run a claims history report to try to match the specific amount requested or to max out the account. Please request the prescriptions print out from your pharmacy, as we are no longer able to run the history on pharmacy benefits. HRA checks are run every Thursday. The request for the HRA must be received by the Fund office by the Friday preceding the next HRA check run. Your request can be sent via mail, fax, or email.

QUESTIONS & ANSWERS

Lately, there have been several of the same questions asked by different members and we would like to explain them.

If I am retiring and only worked 400 hours in the calendar year, that I am planning on retiring, will I get a full pension credit? *No. You get a full credit if you work 1600 hours in the calendar year that you retire.*

If I am retiring and only worked 400 hours in the calendar year that I am retiring will I get free insurance for a full year. *No. Your insurance* is based on the hours you worked in the eligibility quarters.
